WKDU is a progressive radio station. As such, the DJs tend to know a lot more about new record releases before they come out. So here are some newly released records, records that aren't out yet and some older ones that get airplay on 'KDU.

First of all, July looks good for Relativity. Scheduled is a new release from Thelonius Monster called Next Saturday Afternoon. Also a record which will probably be out before this goes to print, the Accused - More Fun Than an Open Casket Funeral. Licensed The Wailing Ultimate is a Records released domestically include Einsterzende Neubaten's 5 on the Open Ended Richter Scale, a Foetus 12" called Bedrock, Biff Bang Pow's Oblivion LP and Felt - Poem of the River LP.

In the Industrial category, Waxtrax has released the Finitribe 12" I Want More and a kill death record by Laibach called Opus Dei. Subterranean has put out new Controlled Bleeding, Core, which is kind of synthesizerish noise.

The Band of Holy Joy used to be noisy, but Rosemary Smith sounds like the Pogues and Halfman Halfbiscuit. Ministry has released yet another Halloween remix (when will they leave us alone?). New Jesus and Mary Chain isn't as guitar thick, loud as Psychocandy, but this version of Who Do You Love is pretty cool ( so is Kill Surf City, sez Dan).

On Birth records. My Dad is Dead's Peace, Love & Murder is his follow-up to ... And He's Not Gonna Take It Anymore. Both records are worth checking out.

Compilationwise, Mordam's Soweto and Viva Umkhonto stand out (especially Jah Sabi on Soweto). Techo-dance fans can look for Young, Popular & Sexy from Factory, featuring ACR. Miaow Kalima, Railway Children and Shark Vegas. Gevser, from Enigma Records, will turn you on to underground Icelandic bands. Homestead's showcase for some of their hands' earlier releases.

On Shimmy-Disc records, an incredible/experimental compilation of some known and unknown bands entitled 20th Anniversary of The Summer of Love. Primary cuts are those by 1/2 Japanese, Fish & Roses, Sharky's Machine, The Moon, Krackhouse....the list is endless. Shimmy-Disc has also put out and EP by BongWater. Breaking No New Ground; really interesting. Look for some new releases from this cool label soon. Placeho has released new

Mighty Sphincter - In the Kingdom of Heaven and Sun City Girls - Horse Cock Phepner. New Dinosaur You're Living All Over Me is out on SST along with an instrumental album by Blind Idiot God. Screaming Trees have an album out on Velvetone called Clairvoyance,


but their next one will be out on SST

## **HOW TO PREPARE FOR AN EMERGENCY**

On the evening of Thursday, May 14, WKDU hosted the "Spoken Word Performance" of Jello Biafra. lead singer and lyricist of the Dead Kennedys. After weeks of planning and telephone correspondence, the event was finally underway. At 7:00PM people began to filter into Stein Auditorium located in Nesbitt Hall. By 7:15 the influx of people had saturated the seating capacity of Stein Auditorium. Despite this minor obstacle, people continued to file into the auditorium making efficient use of aisle space and standing room in the rear. A table, centerstage, containing various props, incited curiosity, thereby catalyzing the crowd's anticipation.

Dressed in a black trench coat and sunglasses, Jello Biafra made his dynamic entrance. Spoken word is the term given to the first phase of his presentation. It is perhaps the only descriptive term sufficiently ambiguous to express the tremendous diversity of his performance which included recitation of lyrics to Dead Kennedy's songs as well as animated monloques. The sardonic nature of Jello Biafra's performance held his audience in a state of hysterical laughter. To the outside observer, it would appear as those in attendance were being entertained by a comedian. The only notable difference is that when the

laughter breaks, we are given time to think. We are horrified by the unescapable realizaton that our laughter is a defense mechanism against the utter absurdity of the apparent trends toward an Orwellian society.

The second, less structured phase, consisted of Jello Biafra revealing the specific circumstances of his own case. On June 5, 1986. the Los Angeles Attorney General's Office filed misdemeanor charges for the distributon of harmful materials to minors, which carries a maximum penalty of \$2000 and one year imprisonment. The phrase "harmful material" refers to the reproduction of "Penis Landscape," the painting by Swiss surrrealist H. R. Giger, which has been packaged with the album Frankenchrist . Attorney General Edwin Meese referred to the case as a " cost effective method of conveying the message." In other words. Ed Meese is trying to implement the proverbial "see what could happen to you if you take that freedom of expression stuff literally" tactic. What is most distressing is the fact that Meese's statement is an accurate one. The Dead Kennedys are an easy target simply because Alternative Tentacles, their recording label, is small and independently operated. Therefore, they do not have

the financial backing neccessary to engage in a courtroom battle. Also, the Dead Kennedys are well known and respected in the artistic circles who would feel the repercussions of the court decision.

Aware of the ramifications of a quilty plea, Jello Biafra refuses to plea bargain his case. He intends to follow through with a jury trial. In confronting these charges. Biafra has initiated a personal crusade to prevent the infiltration of censorship which is eroding our First Amendment rights. It should be noted that the ruling of this trial will set a precedent for future cases involving censorship entailing bookstores, writers, filmmakers and other artists. In the event of a conviction. the ruling may result in a nationwide domino effect which would be reminiscent of book burning days. In order to finance the cost of a courtroom battle, the No. More Censorship Defense Fund has been established The lowest accumulated cost estimation is \$40,000. However, even this outrageous sum may not, in fact probably will not, come close to compensating court fees. The sole financial resource of the Defense fund is private contributions. THE BLACK **EXPERIENCE** IN MUSIC SUNDAYS



Most of the time at 'KDU you will hear an amazing variety of music; often enough you'll hear mainly progressive sounds, but you'll also hear jazz, experimental, R & B, and even the music of the One and only Mr. F. Sinatra. However a common link between all of this music is the fact that a good portion of it might be prerecorded on tane.

It is surprising to fing out just how much tape is actually used in a radio station: in fact, some are entirely on tape. At WKDU, however, the majority of songs that are found on tape are so because they may be material that is fairly hard to come by (for example, a limited edition record or test pressing). Also a big portion of the tapes we play are also from local bands that usually bring a reel to reel tape or cassette for us to copy. For some bands this is usually the best and easiest way to get airplay.

The actual taped medium that is used at WKDU and virtually all radio stations is something known as a broadcast cartridge, commonly called a "cart." The best way to describe the thing is to compare it to an old style 8-track tape. These were basically an endless loop of tape that would rewind itself onto a spool. The quality of the 8-tracks was never that great, and with the coming of dolby-ized, cassettes with metal tape, etc., the 8-track just faded away.

### STATE OF THE ART

The cart, however, was designed first, and it has still managed to hold on in spite of all new technologies. The reasons have been very simple; they are fairly cheap, and easy to use. Cassettes may have better sound qualities, but it is very tough finding where a song starts on one. In radio, being able to make a smooth transition from one song to another is often very important. The cart, with just one song on each, is just the thing to make life easier for a DJ

Cassettes are still very important in radio, and they are almost always used for presenting longer programs. Philyview is a good example of this. The production people can get the whole show ready and then put it on cassette. This makes it very easy for a DJ to just pop the cassette in the tape player an press a button. He or she will only have to worry about the end of the tape and be ready for it.

The final tape medium that is used in radio is reel to reel tape. With it you are able to get very good sound quality. There are two reasons for this: The equipment is usually top-notch, and the speed at which the tape moves is faster. When magnetic tape is used for recording, there are particles on the tape that relatin the electrical signal. When the tape goes faster, there are more "particles per

note" involved in the recording. This means that less of the signal is lost, guaranteeing true fidelity. At "KDU we try to make an effort to record all of our important events such as our Bandbash, etc. on reel to reel tape. However, the tape itself is fairly expensive, and our machines have seen better days.

As a final note on all this info on recording, we've just read about the introduction of the new digital audio tape for broad cast use. This is the new type of tape that is supposed to have all of the audio quality of a compact disc. It has apparently caused a lot of grief to some of the big record companies because they are all worried about copyright laws, lost profits, and so on. Well apparently that hasn't bothered some of these equipment manufacturers because they're all ready to introduce these new digital tape machines as replacements for the good of reliable cart. For the moment these machines. are just prototypes, but only time will tell if they are the wave of the future.

## **IMPORTS UNDER FIRE**

In August of 1986, the Immigration and Naturalization Service (I.N.S.) proposed new regulations governing visas for performing artists from other countries (H-1 visas). Included within the category of performing artist are folk musicians, reggae musicians, performance artists, dance ensembles, and any progressive and independently labeled band. The proposed regulations are as follows:

- The artist has or will perform as a star or featured entertainer in a major production.
- 2) Artist commands a high salary.
- Artist has achieved extensive commercial success as evidenced by record sales and box office receipts,
- Performances will take place in concert halls with a distinguished reputation.
- Artist has received national or international awards.

The new rules change little of the current regulations, yet when and if they are passed, the requirements will be more rigid and more strict.

Ironically enough, when the issue first arose it had nothing to do with the music industry. The new regulations are a direct result of complaints filed regarding certain Broadway productions. The complaints were filed against foreign theatre ensembles touring the United States.

Various American theatre companies began to witness their jobs being consumed by the excess personnel within the foreign organizations. Identified as excess personnel are the following: make-up artists, stage-hands, lighting and sound personnel. It was these complaints which prompted the INS to consider changing existing regulations. Unfortunately, no one had the foresight to predict the drastic effects it would have on the musical and cultural exchange between the United States and other countries.

Luckily, Leslie Berman of the Village Voice, ethnomusicologist Dr. Lois Kutler of Ambler, PA and others got wind of the impact of the new regulations before the late October deadline for public comment. They managed to mobilize many individuals and musical organizations to write letters and circulate petitions urging the INS to reconsider.

AVID. Artists against Visa Denials, is a group of artists, performers, club owners, promoters as well as cultural and political activists who have united to protest the regulations. AVID began to organize an effort aimed at heightening awareness with the public and in the media. The petition and letter writing campaigns are directed at urging INS to not implement the regulations as written and to eliminate the overtly commercial and restrictive nature of the rules

There has also been a spirited, yet unsuccessful, effort by AVID to meet directly with INS personnel. In each case, the request for a faceto-face meeting has been turned down.

Since that time AVID has continued to press its case. A demonstration with over 200 supporters was held at the offices of INS, on Sansom Street in Philadelphia. AVID has also had its representatives appear on TV and radio programs.

Although these regulations were initially aimed at saving jobs, they are nonetheless threatening to put many promoters and club owners out of business. In addition, these regulations are cutting into the core of the underground music industry and closing the door on cultural exchange. The passing of them simply infringes upon our right of free choice and brings us vet one step closer to selective censorship of the music and performing arts industry.

A spectre is haunting the underground music scene the spectre of Big Business I wonder how long before it completely takes over. I can just see it now: the Other Hotel Productions present the Meatmen with special quests 7 Seconds at the Spectrum, all for just \$15 in advance. This horrible event is not as ridiculous as it would have seemed a few short vears ago. Why? Because hardcore is now becoming popular and there is an opportunity to make money from it. Independent labels now go major, or else become puppets of the major labels. Hardcore bands can now be seen on MTV (check out 120 Minutes for the Cro-Mags and Bad Brains videos). The whole idea of independent music is being flushed down the corporate rock toilet.

The first big question that could be asked is "why is this such a bad thing?" Punk Rock originally was a rebellion away from monolithic. boring, corporate rock. What ever happened to the D. I. Y., "Do it Yourself", attitude that once prevailed? By doing it without the corporations the music can say whatever it wants to. The corporations are not going to put out records with messages that might offend the wrong people (ask the Beastie Boys about big companies changing and deleting songs). There is artistic freedom in independent records which cannot be obtained from the big companies. Would a major label have released Frankenchrist with the infamous poster? (what about the record? - ed.) Big record companies are just looking for what sells. In America that's not intelligent. thought-provoking music, but rather, ignorant shit. Take the Beastie Boys - They are making major league bucks with no talent, showing just how stupid the American public is.

The biggest bitch I have is not with the record companies, but with the "in it for the money" new promoters. There were and still are some promoters who put on shows for enjoyment rather than profit. Until recently, Philly shows were put on with that in mind. Now we have a promoter from Jersey sticking his big fat hand into Philly. Soon we can see shows with all of the "big" bands that use him as a booking agent. A booking agent who does 7 Seconds and all of these other bands will think they are Bon Jovi. Now he can have shows in two scenes: Philly and South Jersey (at least this will mean that certain bands that he prohibits from playing Philly so that people will go to Jersey can now play Philly, too). I can't wait to get to shows in Philly and find out that one of the headlining bands didn't show, just like in Jersey. There is only one thing that can be done to return shows to real promoters: boycott shows put on by those who are looking for bucks at your own expense. After losing his ass on a few shows in Philly, maybe he will crawl back under his rock in Jersey.

Songs like "A Skeleton in the Closet" and "Amongst the Living" contain hard-driving rhythm and ripping lead guitars. Any true metalhead should not be without this record. One surprising thing about this album is that Anthrax display a bit of social conscience on songs such as "Indians" and "One World". That should really

Grey March, out of Baltimore,
have released thier debut LP
on Unconscious Records. In
tracks such as "Something's
Missing" and "Forced by Pressure," they sound fast and loud.
Then the beat is slowed down
somewhat on "Way of the
Cross," but a high level of intensity persists. The music
features distorted guitar parts
and pounding drums, creating
a death-rock like sound forcing energy through you.

Louis Burch belts out the vocals like he means it, but with a tone and style that is a cheap rin-off from Ian Curtis, former vocalist of Joy Division (very former - ed). The difference is. Curtis sang meaningful material, and Burch pours out lyrics that go straight through you, causing you to wonder about relevance. Some of their more clever lyrics are "Only vertical, sometimes, surgical, sadly it was logical. but I don't know which way to go, I just don't know." If that's their best, imagine their worst! Though the lines lack content, they are cranked out with great energy, allowing the band to come across well.
